The 41st National Veterans Wheelchair Games (NVWG) were held in Tempe, Arizona this past July. This dynamic event is co-sponsored by the Department of Veteran Affairs and PVA. 2022 NVWG had more than 300 veterans participate! Due to the COVID-19 pandemic, NVWG safety measures required athletes to participate in the games being split; this year, everyone was able to compete together! Additionally, all 20 events were held indoors due to the extreme, 110-plus-degree, record setting heat in Arizona. Similar to the 2021 NVWG, there were not any wheelchair track events, but the 2022 NVWG held field events (discus, javelin, and shot put).

Other events held at the 2022 NVWG were wheelchair rugby, wheelchair basketball, powerlifting, air rifle, air pistol, wheelchair curling, and adaptive pickleball.

Team Wisconsin was represented by 14 athletes from across the state. These fourteen athletes braved the hot weather of Arizona to win an array of medals across a variety of activities. PRESIDENT'S REPORT

Twenty-one years ago many things changed in the world forever. As September 11 has passed I want to take a moment to think remember all of the individuals who needlessly lost their lives a result of the twin towers attack - those in the building plus all of the brave souls that put forth valiant rescue attempts.

I think it is also important to remember the changes that took place post 9/11 that have affected us all on a very personal basis as veterans, and as members of VSOs, such as PVA. When I entered military service, as the tail end of the Vietnam War, the military was generally viewed very negatively by the public. Indeed, I have vivid memories of having things thrown at/on me, spit on, called a warmonger(and much worse), etc. - all for simply defending my country. With the 9/11 tragedy, public sentiment towards the military, veterans, and protecting our lives and freedoms, changed dramatically. In short order, after this singular event, our military-connected sector was belatedly now seen as "heroes", "brave", "selfless", "necessary", etc. With this change in public sentiment came a 180-degree reversal in how not only how we are now viewed, but also how we are now treated. Instead of uniformed personnel being pointed at and called names, total strangers now "thanked us for our service", ask uniform personnel to take their seats in first class or go to the front of the line, Veteran discounts were created, etc.

- The changing environment also fundamentally changed the world for veteran service organizations
- such as PVA, and even our own individual chapter. This new appreciative environment supported the
- formation of a number of new veteran-oriented organizations such as Wounded Warriors, etc., it saw a number of new legislative bills and initiatives that increased military spending, it caused major improvements in VA benefits and medical care, etc. This change in the public's perception also increase the number and size of their donations and their volunteer hours. Indeed, the direct and indirect benefits that have trickled down to all of us, and our very own chapter, simply because of what happened on 9/11, have truly been astounding.


EXECUTIVE DIRECTOR'S REPORT



NATIONAL SERVICE OFFICER REPORT

I'd like to start off by introducing myself. My name is Brenda Stencil, and I'm the new National Service Officer (NSO) for Paralyzed Veterans of America - Wisconsin Chapter. I am originally from Edgar, Wisconsin and currently in Cedarburg, Wisconsin.

I retired from the U.S. Navy in August 2016. I served on two Navy warships, the USS RUSHMORE (LSD 47) homeported in San Diego, California and USS ESSEX (LHD 2), homeported in Sasebo, Japan. I completed tours in Honolulu, Hawaii (Submarine Squadron 7), San Diego, California (SEAL Team FIVE), St. Louis, Missouri (Navy Recruiting District), Pensacola, Florida (Navy Advancement Center), and other staff positions in Arlington, Virginia, and San Diego, California. Previously, I worked at Milwaukee VA Regional Office as a Veterans Service Representative.

As the PVA NSO, I'm an accredited representative for VA benefits. VA benefits include but are not limited to compensation and pension, special monthly compensation and pension, aid and attendance and housebound, insurance, educational assistance, vocational rehabilitation, dependent's benefits, and burial and death benefits.

I assist veterans, surviving spouses, children and parents throughout the entire claims process, and monitor the timely progress of submitted claims. I also work closely with the staff at VAMC spinal Cord Injury/Disease Center to monitor and report health care issues to access and quality of care for all veterans with spinal cord injury or disease, ALS, and MS.

Honoring our PACT Act of 2022, Signed into Law



The Honoring our Promise to Address Comprehensive Toxics Act of 2022, known as the Honoring our PACT ACT of 2022, is an Act of Congress intended to significantly improve healthcare access and funding for veterans who were exposed to toxic substances during military services.

The act was first introduced on June 17, 2021, by Representative Mark Takano (D-CA). The House of Representatives passed the bill by 256-174 on March 3, 2022, [1][2] and passed the Senate by 84 - 14 on June 16, 2022. Due to a previously unnoticed technical constitutional issue with the bill, a revised version needed to pass the Senate again, but failed a cloture vote 55-42 on July 27, 2022, after 25 Republicans flipped their votes. Republicans cited a preexisting provision that made previously approved veterans' funding mandatory rather than discretionary as justification for their vote changes, while erroneously claiming the provision would increase spending authority unrelated to burn pits.

The failed cloture vote occurred immediately after the bipartisan CHIPS Act passed the Senate, after which Senate Majority Leader Chuck Schumer and West Virginia Senator Joe Manchin announced their agreement on the Inflation Reduction Act. The act would be approved through reconciliation, which would require only 50 votes plus Vice President Harris as the tie-breaking vote as Senate President. The failed cloture vote on the veterans' bill was widely seen from Democrats and veterans as retaliation for agreeing on the inflation bill.

Dozens of veterans, many of whom were exposed to burn pits themselves, continuously camped outside the United States Capitol in protest for five days. The bill passed the Senate by 86 - 11 on August 2, 2022, amid pressure from the veteran groups and other activists. There was no change in the funding mechanism or the bill's text between the first and the second Senate vote. On August 10, 2022, it was signed into law by President Joe Biden.

Program Overview:

Paralyzed Veterans of America - Wisconsin Chapter (PVA-WI) has started a partnership with the Elizabeth Dole Foundation (EDF) to support our families, of full members, who need additional support with caregiver respite and caregiving. The Elizabeth Dole Foundation has partnered with the U.S. Department of Veterans Affairs to create a brand-new program, Respite Relief for Military and Veteran Caregivers. This highly needed program provides thirtyfive hours of free care. PVA-WI has worked with EDF and CareLinx, the company providing caregiving services, to offer fifteen additional hours of care to our full members, who are eligible to participate in this program. PVA-WI will be billed for the fifteen additional hours of care. PVA-WI is excited to partner with these organizations and serves as a pilot program.

Ervin Mulkey received a new mobile chair, specially designed to help him play adaptive sports, and go hunting and fishing. The chair looks similar to a standard mobile chair, but instead of wheels, it has tank-like tracks to get through rough terrain. Mulkey was surprised with the chair by the Paralyzed Veterans of America - WI Chapter at an event in Madison. He thought he would be speaking about the positive impact that adaptive sports has had on his life. "I'm still blown away," he said, "I don't know what to think." Mulkey said that, in the past, he's had to rely heavily on his son when the pair want to go hunting or fishing. Now, he won't have to worry. "Him and my daughter, they've supported me so much," he said. "More than I think I deserve." Mulkey is very familiar with the tank tracks that adorn his new chair. He served as a tanker while in the Army. He was injured during Operation Desert Storm. When that first happened, "I was in a very dark place," Mulkey said. "It was adaptive sports, and the PVA with the wheelchair games that literally saved my life." Mulkey is looking forward to spending more time hunting and fishing with his family, especially now that he'll be able to move more freely on his own with both the track chair and PVA-WI trailer.
