- 2025 PVA-WI Board of Election Results

- Chase Grant Writing Consultant Services \$20,000 for FY2025
 - o Todd Drazy requested further explanation regarding the proposed grant writing consultant services. Scott Griffith provided background, noting that this proposal refers to Chase Grant Writing Consultant Services, which was introduced at the previous board meeting. Scott met with the consultant team to review relevant data and discuss potential outcomes. Based on that meeting, the recommendation is to engage Chase under a trial contract to pursue four program grants. Each grant will have a minimum target amount of \$50,000, with a preferred target of \$100,000. The consultant will be compensated with a flat fee of \$20,000 for the preparation and submission of the four grants. This would be PVA-WI's first time hiring a grant writing consultant. If successful, these grants would represent the largest funding amounts ever received by PVA-WI.
 - o Gary Stott made a motion to approve the trial with Chase Grant Writing Consultant Services. Michael Thomas seconded the motion. All votes were accepted, no nays, and the motion was carried.
